"Off-scale salaries" and other components of pay (i.e., a salary that is higher than the published system-wide salary at the designated rank and step) are offered when necessary to meet competitive conditions, qualifications, and experience.

QUALIFICATIONS: We offer a unique opportunity for a Veterinary Anatomic Pathologist who has an existing expertise or an established interest in developing an expertise in dermatopathology to join our outstanding team of Anatomic Pathologists and Dermatologists at UC Davis. The successful applicant will support the clinical service and teaching missions in the Department of Pathology, Microbiology and Immunology (PMI) within the School of Veterinary Medicine. This is a fully-funded, clinical-track faculty position with 70% clinical service effort. Board certification or eligibility for board certification by the American College of Veterinary Pathologists (ACVP) or European College of Veterinary Pathologists (ECVP) is required. Demonstrated aptitude and experience in teaching is required. Clinical experience and competence in Anatomic Pathology diagnostic service is required. The dermatopathology case load represents 15-20% of biopsy submissions, and consists of mandatory special reviews from the Veterinary Medical Teaching Hospital (VMTH) Dermatology

A successful career as faculty in PMI relies on the maintenance of a productive and collaborative research program. Opportunities for engagement within PMI include but are not limited to, microbial pathogenesis, host-microbe interaction, vaccinology, immunopathology, vector-borne and wildlife and aquatic disease. Faculty within the Dermatology Service specialize in genodermatoses of companion animals; clinical management of infectious, sterile inflammatory, and autoimmune skin diseases; and cutaneous manifestations of systemic disease. The School of Veterinary Medicine embraces the One Health concept and offers many opportunities for collaboration on projects that span animal, human, and ecosystem health.

The successful candidate will have excellent interpersonal and communication skills, a demonstrated ability to work with others in a collegial team atmosphere, and strong or potential accomplishment in areas contributing to diversity, equity, and inclusion. RESPONSIBILITIES:

Teaching: 1) participation in didactic lectures, discussions, and laboratories in the DVM professional curriculum; 2) clinical teaching in the VMTH; 3) participation in the resident training program of the VMTH; and 4) participation in the graduate academic programs (MS and PhD) of the campus if appropriate. A demonstrated commitment to the training of veterinary or other biomedical scientists and innovative teaching methods is preferred. Creative Work: Faculty are expected to advance the clinical discipline through creation, and dissemination of new knowledge with documentation in peer-reviewed publications. Creative/scholarly activities are required for individuals in this series, but in view of the increased responsibilities for clinical service and teaching, the type of scholarly activity may focus primarily on integrating/improving clinical care, conducting clinical research studies and/or improving veterinary medical education.

Clinical: The position includes 70% diagnostic service in the VMTH. The individual will be responsible for directing, instructing and supervising veterinary students, residents and visiting scholars; providing diagnostic service; and advising and consulting with clinicians and residents.

Service: The University of California has a system of shared governance. Active participation in committees, professional organizations, continuing education and other appropriate outlets is required.
